Introduction

Thank you for the opportunity to submit on the Waikato Regional Councils proposed Plan Change 1.

The Kelliher Charitable Trust farm 723 ha on Ponganui Rd, Onewhero. This is a Priority 1 catchment, of the Opuatia Catchment.

The Kelliher Charitable Trust was established in 1963 and at that time, Puketutu Island was vested into the Trust. The Island had been owned by Sir Henry Kelliher since 1938, and during his tenure had transformed the property from a desolate Island into an outstanding farm.

In 2011 the property was transferred to Watercare Services and the Auckland City Council, with the intention to make it into a regional park. It is acknowledged the environmental protection work the Kelliher Charitable Trust had done was of the highest standard.

The Kelliher Charitable Trust wished to continue farming so purchased a farm in the Onewhero district, and extended this in 2016.

The farm they purchased needed extensive work. The Kelliher Charitable Trust was one of the first in the Waikato to complete a Land Environment Plan 1, so they could plan their works over time. The Trust has a systematic plan over 25 years to improve the environmental sustainability and profitability of the farm. This work has begun and is carried out to a standard that will last 50 years. One of the first projects will be to ensure that the native bush is fenced off and made stock proof.

The Kelliher Charitable Trust supports the vision and strategy of the Healthy Rivers proposal, and are actively working towards achieving these goals on their own property.
