Waikato Regional Council hereby gives notice of the availability of the summary of decisions requested by persons who made submissions on Proposed Change 1 to the Waikato Regional Policy Statement under the Resource Management Act 1991 (RMA) and of the right to lodge further submissions. Making a further submission

The following people may make a further submission:

- any person representing a relevant aspect of the public interest; and
- any person that has an interest in the proposed policy statement or plan greater than the interest that the general public has; and
- the Waikato Regional Council itself.

A further submission must be limited to support of or opposition to a submission that has been made on Proposed Change 1 and must seek that the submission be allowed or disallowed (in whole or in part).

A further submission needs to contain all of the information detailed in Form 6 of the Resource Management Forms, Fees and procedures Regulations 2003.

You may submit a further submission by sending a written or electronic submission to Waikato Regional Council by one of the following methods:

A copy of your further submission is also required to be sent to the submitter to which your further submission relates, no later than 5 working days after lodging your further submission with the Waikato Regional Council (refer clause 8A, Schedule 1, RMA). The summary of decisions requested is publicly notified on Tuesday 31 January 2023. Further submissions must be lodged with Waikato Regional Council by no later than 5pm Wednesday 15 February 2023, which is 10 working days after the day on which public notice is given.

A copy of the further submission must be served on the original submitter to whom the further submission relates no later than 5 working days after the date the further submission is lodged with the Waikato Regional Council.
